

Joint Statement between the Transitional Federal Government of Somalia

And

The Alliance for the Re-liberation of Somalia

On Somalia Emergency and Drought Relief (SEDR)


In line with the Djibouti Agreement between the TFG and ARS to end hostility in their country and work together for the peaceful reconstruction of Somalia,

And

Taking into account the fact that the parties jointly declared that the people of Somalia need an immediate humanitarian assistance (paragraph 6 of the Joint Communique of 20 August, 2008).

1. The two parties agree to hereby establish a national emergency and relief office that commences its primary activities from Djibouti. The office comes under the supervision of the High Level Committee.
2. The High Level Committee establishes a sub-committee of five members (2 TFG, 2 ARS, 1 civil society) that will act as the executive board of the new initiative.
3. The sub-committee will meet to define the main activities: install the emergency office, recruit professional staff and approve the initial budget, etc.
4. Agree to officially open the emergency and relief office a week after signing this Statement.







1. Labadda dhinac waxay ku heshiiyeen in ay sameeyaan xafiis qaran oo qaabilsan hawlaho kaalmadda deg-degta ah, kaas oo ka bilaaba hawlgalkiisa ugu wayn Magaaladda Jabuuti. Xafiisku wuxuu hoos imanaya Guddiga Heerka Sare.
2. Guddiga Heerka Sare wuxuu sameeynaya guddi hoosaad ka kooban shan xubnood (2 TFGda, 2 ARSta, 1 Bulshada rayadka ah), kaas oo noqon doona Guddiga ugu sareeya ee howlgan kan cusub.
3. Guddi hoosaadku wxuu yeelan doonaa shir si uu u qeexo howlihiisa muhiimka ah: in uu dhiso xafiiska arrimaha degdega, in uu shaqaaleeyo shaqaale xirfadlayaal ah wuxuuna ansixin doona miisaaniyadda.
4. Labadda dhinac waxay ku heshiiyeen in si rasmi ah loo furo xafiiska gargaarka arrimaha degdega ah muddo hal asbuuc ka dib, saxiixa qoraalkaan.
